



Aerial Operations

Should you wish to operate any equipment in the air (unmanned drone, kite flying etc) or provide a fireworks display during your event, the following need to be met because of the venue's close proximity to Auckland Airport and the direct overhead flying zone.

REMOTELY PILOTED AIRCRAFT (RPA) / DRONES

1. The drone must be operated by a competent person.
2. The operator must keep a visual sight of the drone always when operating it.
3. The drone cannot be operated higher than 100 feet (or approximately 30m) or flown above cloud or in heavy fog.
4. When operating the drone outdoors, it can only be operated during daylight hours.
5. Authorisations must be requested through AirShare (www.airshare.co.nz) To request an authorisation you will need to register and log into AirShare. Log your flight using the "Log a Flight" button.
6. Do not operate over dry flammable vegetation.
7. Provide a safety plan to the Venue with a hazard management plan.
8. Use the attached map to show where you intend to operate the RPA.

NOTE: If using a drone indoors, the expectations are that the operator is competent and must keep a visual sight of it always and able to navigate the technical / electrical / building features in the venue. The client / operator must also provide a safety plan on how they intend to keep all other venue users safe when operating the drone indoors.

KITE FLYING

1. The kite remains more than 4km from the airport boundary.
2. The weight of the kite does not exceed more than 15kg.
3. The kite cannot be flown higher than 100 feet (or approximately 30m) or above cloud or in heavy fog.
4. The horizontal visibility is not less than 4 km.
5. Provide a safety plan to the Venue with a hazard management plan.
6. Use the attached map to show location of kite flying.



FIREWORKS

It is your responsibility as the hirer to ensure that your pyrotechnic provider submits the following to the Venue prior to the event date:

1. Application for Venue consent detailing:
 - a. Approved handler in charge's name and contact details
 - b. Approved handlers test certificate details
 - c. Details of the display
 - d. Site plan of the display
 - e. Additional pyrotechnic handler personnel names and details
2. Approval sought from the New Zealand Fire Service
3. Approval sought from Civil Aviation Authority & Auckland Towers
4. Once the consent is given, the approved Test Certificate to be received containing:
 - a. Name of the person or company commissioning the display
 - b. Location of the display
 - c. Date and time of the display
 - d. Type and level of display approved
 - e. Type of pyrotechnics to be used in the display
 - f. Approved handler in charge
 - g. Additional approved handler assistants
5. Provide a safety plan to the Venue with a hazard management plan.
